



**Oklahoma Unsecured Installment Loan  
Fee Schedule and Examples**

- Amounts vary from \$50 to \$700 in \$10 increments
- The finance charge varies based on the amount borrowed
- Annual Percentage Rate (APR) varies based on loan term and amount borrowed
- Loan term varies from 2 to 5 months based upon amount borrowed
- Payments are due monthly
